2. Capital Facilities Update. Chief Hartin reported, he met with Whidbey General Hospital (WGH) Board members and Ms. Gerri Forbes (WGH CEO). He shared with them the district's desire is to expand Station 51 by moving in where the EMS office is currently located as they expand off the back of the station. WGH's board shared they are not prepared to say what action they would take regarding Station 51 until the end of April. Based on this information, the district's consultant has recommended the district defer any action on a bond until 2017. This will mean the need for a larger turn out, but gives the district a great opportunity for public communication and time to build a solid plan on what we want. WGH Board members and Ms. Forbes agreed it is in the best interest of the community to continue to work together.
