Call to Order

This meeting of the Central Whidbey Island Fire & Rescue (CWIFR) Board of Fire Commissioners was called to order by Chairperson Steve Hutchinson at 1:00PM.

Consensus Approval of the Agenda

The Chair received consensus approval of the agenda.

New Business.

1. Exit Audit Conference with Washington State Auditor. Office Manager Kim Harpe provided the Board with preliminary draft copies of the Financial and Accountability Audit Reports the state auditor would cover during the exit audit conference.

State Audit Managers Andy Abjorsen, Deena Garza and Assistant Audit Manager Elizabeth Corcoran were called and provided the Board via speaker phone a detailed explanation of the audit process. The auditing staff complemented the District's transparency and efforts to work with them and also immediately implement recommendations for process improvements discussed during the audit process. The Auditor did not identify any deficiencies in internal controls considered to be material weaknesses and stated the financial statements were fairly stated for 2010-2014, in all material respects in relation to the financial statements taken as a whole.

2. Orientation of Recue Boat. The Board proceeded to the Keystone Ferry and boarded the districts rescue boat for an orientation with Captain Jerry Helm.
