Motion to approve or disapprove Signing an Underwriting Engagement Letter with D.A. Davidson & Co. Office Manager Kim Harpe provided the Board with an updated Capital Facilities and Equipment Option Plan and a generic bond payment spreadsheet provided by Mr. Jim Nelson at D.A. Davidson & Co. She stated, "Under new laws underwriters can only share generic numbers for debt capacity, payback rates and bond interest rates. By signing the engagement letter, Mr. Nelson would be able to provide actual numbers related to the district". Office Manager Harpe shared, "Chief Hartin is looking for the Boards direction regarding the bond at their special meeting scheduled for August 23rd so the 2017 budget and long term capital plan can be finalized".

Commissioner Paul Messner asked, "If a competitive bid process was or should be done prior to choosing an underwriting bond company?" He also stated, "He would like the district's attorney to review the engagement letter as well." Office Manager Kim Harpe stated, "She did not think a competitive bid process was required, but would have a definitive answer for the Board prior to their special meeting scheduled for August 23rd and she would send the letter to the district's attorney". Commissioner Paul Messner moved and Acting Chair Cheryl Engle seconded to table this motion until the Board meets on August 23rd.
