# Board of Fire Commissioners Special Meeting Minutes April 25, 2017

#### **Call to Order**

This meeting of the Central Whidbey Island Fire & Rescue (CWIFR) Board of Fire Commissioners was called to order by Board Chair Cheryl Engle at 10:00 hours.

## **Good of the Order/Announcements**

May XX, 2017 (TBD) Commissioner's Workshop

Chief Hartin briefed the Board regarding Washington States minimum wage increase. He shared, he had sent a letter to Mr. Roger Meyers (WhidbeyHealth EMS Director, WhidbeyHealth) in December 2016 to open the BLS contract to discuss the annual reimbursement to the district as agreed to previously and never received a reply.

Chief Hartin met Mr. Meyers in January and told he would arrange a meeting with Ms. Geri Forbes (WhidbeyHealth, CEO). Chief Hartin stated, "He had not heard anything back from anyone at WhidbeyHealth, so he had Offfice Manager Kim Harpe call Ms. Forbes and schedule a meeting in March". Chief Hartin met with Ms. Forbes & Mr. Meyers and was told, "They understand and agree that something needs to done regarding the BLS Agreement, but at the present time WhidbeyHealth had a

number of situations that could potentially have a financial impact to the hospital so the soonest they would be able to engage in another conversation would be September2017". Chief Hartin shared, "He is hopefully optimistic that we will have movement this year, but it could very well be next year as well".
