Remaining work involves testing the current backup system to ensure functionality, updating the interface used to access the printer/copier from individual computers and providing information necessary to describe our hardware and software computing environment. The Administrative Division is exploring options to address the District's ongoing IT service needs inclusive of hardware and software service, technology planning and continuity of operations planning".

2. WhidbeyHealth Hospital Inter-Local Agreement (ILA) Update. Chief Hartin stated,"He and Chief Kirko met to collaborate on the language for the draft proposal of the WhidbeyHealth Hospital Inter-Local Agreement (ILA)". Chief Hartin and CWIFR Board Chair, Steve Hutchinson also met with North Whidbey Fire and Rescue's Board Chair, TJ Lamont, and Fire Chief Mark Kirko, to review the draft proposal and he stated, "He felt the meeting was very productive".

3. Discussion of Station 53 Construction Project Update. Chief Hartin shared, "The civil engineering plans for review would hopefully be available in the coming weeks. The holdup was, they are waiting on a determination to see if a wild life biologist is needed in regards to the nesting osprey".
