Regarding Per Diem and Travel Expenses)

THE FIRE COMMISSIONERS OF CENTRAL WHIDBEY ISLAND FIRE AND RESCUE HAVE MET AND DETERMINED THAT:

WHEREAS, RCW 42.24.090 allows per-diem in lieu of cash/receipting for approved travel; and,

WHEREAS, the District Commissioners have reviewed the necessity and feasibility for establishing and maintaining such travel expense procedures;

NOW THEREFORE, BE IT RESOLVED by the Board of Fire Commissioners of Central Whidbey Island Fire and Rescue to hereby adopt the following per diem procedures:

1. Per Diem and mileage/travel expenses are hereby created and established pursuant to the provisions of RCW 42.24.090.
2. Fuel costs shall be reimbursed upon presentation of a receipt, and the mileage rate shall be calculated using the prevailing IRS rate if a non district owned vehicle is used. If a District vehicle is available and the individual chooses to travel in his/her private vehicle, the mileage reimbursement will not apply.
3. The Per Diem rate paid in advance of travel shall be determined using the current published rates in effect from the US General Services Administration at www.gsa.gov for the general area of travel. If a meal is provided (such as included in the conference registration, etc.) the meal amount will be deducted from the advance per diem.

PER DIEM AND TRAVEL EXPENSES)**

RESOLUTION #97-03

WHEREAS, currently the District is on an accountable reimbursement method of funding travel meals and non-lodging expenses, requiring individuals to obtain receipts for each meal expense while traveling.

WHEREAS, the State Auditor has explained the advantages of a per-diem in-lieu payments system in accordance with RCW 42.24.090.

WHEREAS, the Board of Commissioners have reviewed the necessity and feasibility for establishing such travel expense procedures.

NOW, THEREFORE, BE IT RESOLVED that the Board of Commissioners of Central Whidbey Island Fire & Rescue hereby adopts the following:

1. Per diem and mileage/travel expenses are hereby created and established pursuant to the provisions of RCW 42.24.090.
2. Fuel costs shall be reimbursed upon presentation of a receipt, and the mileage rate shall be the prevailing IRS rate if a private vehicle is used. If a District vehicle is available and the individual chooses to travel in his private vehicle, the reimbursement payment will not apply.
3. The per diem rate paid in advance of travel shall be \$34 per day, based on \$8 for breakfast, \$10 for lunch and \$16 for dinner. If a meal is provided (such as included in conference registrations, etc.), the meal amount will be deducted from the advance per diem.
