WHEREAS, the Board of Fire Commissioners of Central Whidbey Island Fire & Rescue has met and considered its budget for the calendar year 2011; and

WHEREAS, the Board of Fire Commissioners of Central Whidbey Island Fire & Rescue after hearing and after duly considering all relevant evidence and testimony presented, determined that Central Whidbey Island Fire & Rescue requires a regular levy in the amount of \$1,900,000.00, which includes an increase in property tax revenue from the previous year, and amounts resulting from the addition of new construction and improvements to property and any increase in the value of state-assessed property, and amount authorized by law as a result of any annexations that have occurred and refunds made, in order to discharge the expected expenses and obligations of the district and in its best interest; now, therefore,

BE IT RESOLVED by the Board of Fire Commissioners of Central Whidbey Island Fire & Rescue that an increase in the regular property tax levy is hereby authorized for the 2011 levy in the amount of \$1, 900,000.00 which included a percentage increase of at least 1% from the previous year, or the greatest levy dollar amount allowable under Washington state law including any banked amounts accrued from previous years.

This increase is exclusive of additional revenue resulting from the addition of new construction and improvements to property and any increase in the value of state assessed property, and any additional amounts resulting from any annexations that have occurred and refunds made.
