#### **Finance Officer's Report**

Office Manager Kim Harpe presented the board with the Monthly Budget Position as of February 12, 2015.

#### **Unfinished Business.**

The Board addressed the following items of old business:

1. Commissioner Cheryl Engle moved to approve and Commissioner Steve Hutchinson seconded approving The Purpose, Scope & Policy for SOG 4.8.2 "EMS Documentation".

Action: Approved Unanimously.

2. Follow-up Discussion on Interim Financial Guidance. At the Board's previous meeting Chief Hartin asked the Board to answer the following questions to help guide staff in the development of a Long Term Financial Plan.

a. If the staff should develop the District's Long Term Financial Plan to include the use of voter approved debt to address capital facility needs? If yes,

b. Given the pending need for a lid lift to maintain current service levels beyond 2020, when should the district consider presenting a bond measure to the voters (before or after the lid lift?).

After a lengthy discussion, Chief Hartin clarified what he understood the board's answers to be for the above questions:

- The Board confirmed staff should develop the District's Long Term Financial Plan to include options for use of voter approved and non-voter approved debt to address capital facilities needs.
- Complete the Standard of Cover before going to voters and say we are intending to remodel and build new stations
- Have a definite sense of the projected costs at each of the stations
- The district should be in a position to act when the hospital starts their upgrade to the EMS Facility at Station 51 so as not to get building and land locked. (WGH does not have a definitive date for this project at this time)
- Prior to a Maintenance Facility being constructed, confirm if other agencies would be agreeable to contract with CWIFR for their vehicle maintenance
