Board of Fire Commissioners Meeting Minutes

May 12, 2015

Call to Order

This meeting of the Central Whidbey Island Fire & Rescue (CWIFR) Board of Fire Commissioners was called to order by Acting Chairperson Cheryl Engle at 17:00 hours.

Consensus Approval of the Agenda

The Chair received consensus approval of the agenda.

Input from the Public

Acting Chairperson Cheryl Engle asked the public for comments. Mr. DeLay stated, "He knew the Board would be discussing the formation of a non-profit water system for the respective properties on Day Road currently being served by Tallman Water Systems". Finance Officer's Report

Office Manager Kim Harpe presented the board with the Monthly Budget Position as of May 12, 2015 and reported "budget lines needing adjustments would be addressed in the proposed 2nd Quarter Budget Adjustments".

Unfinished Business

 Commissioner Steve Hutchinson moved to approve and Acting Chairperson Cheryl Engle seconded approving the formation of a non-profit corporation to serve as a Water Association to manage the water system serving the respective properties on Day Road in Greenbank currently known as the Tallman Water System.

Action: Approved Unanimously.

2. Acting Chairperson Cheryl Engle moved to approve and Commissioner Steve Hutchinson seconded approving the addition of a new section addressing "Transparency in Government" to the Commissioner's Handbook.

Action: Approved Unanimously.

New Business

1. Commissioner Steve Hutchinson moved to approve and Acting Chairperson Cheryl Engle seconded approving the extension to the collective bargaining agreement through November 30, 2015.

Action: Approved Unanimously.

2. Commissioner Steve Hutchinson moved to approve and Acting Chairperson Cheryl Engle seconded the motion to approve entering into "Assistance to Firefighters Grant Program Inter-local Agreement" between the City of Oak Harbor, Camano Island Fire & Rescue, North Whidbey Fire & Rescue, South Whidbey Fire and EMS and Central Whidbey Island Fire & Rescue to provide radio system upgrades.

Action: Approved Unanimously.

3. Commissioner Steve Hutchinson moved to approve and Acting Chairperson Cheryl Engle seconded approval of the "2nd Quarter Budget Adjustments"

Action: Approved Unanimously.

4. Commissioner Steve Hutchinson moved to approve an "Inter-fund transfer from the General Fund to the Capital Fund in the amount of \$109,195.19". Acting Chairperson Cheryl Engle asked Finance Officer Kim Harpe for an explanation. Finance Officer Kim Harpe stated "All revenue and property taxes collected are deposited in the General Fund and cannot be moved into any other fund without the Board's approval of an inter-fund transfer. Previously, the district had all of its revenue inside the General fund and earmarked money for separate funds was outlined in the budget. In an effort to provide better transparency and remove the risk of co-mingling of money between funds, individual funds were established at the Treasurer's Office. Acting Chairperson Cheryl Engle seconded the approval of this motion.

Action: Approved Unanimously.
