# **Board of Fire Commissioners Meeting Minutes**

June 30, 2015

#### **Call to Order**

This meeting of the Central Whidbey Island Fire & Rescue (CWIFR) Board of Fire Commissioners was called to order by Chairperson Paul Messner at 16:00 hours.

#### **New Business**

The Board, Chief Ed Hartin and the Marine 5 Working Group (Consisting of Acting Captain Jerry Helm, Firefighters Dillon Rogers, James Meek, Robert Moore and Greg Behan) reviewed the working groups proposal to purchase a 2006 25ft Safe Boat.

After much discussion, Commissioner Cheryl Engle moved to approve modifying the CWIFR Capital Projects Plan by moving the replacement of Apparatus 0301 (Marine 5) from 2016 to 2015; authorizing an increase to this project from \$100,000 to \$117,000 and adjusting the 2015 CWIFR Capital Budget by \$117,000. Commissioner Steve Hutchinson seconded approval of this motion.

Action: Approved Unanimously.

Commissioner Steve Hutchinson moved to approve the purchase of a 26' Safe Boat not to exceed \$117,000 inclusive of taxes and shipping. Commissioner Cheryl Engle seconded approval of this motion.

Action: Approved Unanimously.

Commissioner Steve Hutchinson moved to approve the purchase of a 2015 Chevrolet Silverado ¾ Ton Pickup Truck using the Washington State Department of Enterprise Services (DES) Contract not to exceed the amount of \$44,093.26. Commissioner Cheryl Engle seconded approval of this motion.
