All Hazards Mobilization

Wildland fires are a growing threat in the Western United States. The wildland fire season has been getting longer and areas such as western Washington that have not typically seen severe fires have been significantly impacted. With our temperate and relatively moist climate, Whidbey Island has been less impacted than other areas, but this is likely to change.



All communities have the potential for incidents that far exceed the resource capability of local response agencies. The Washington State Patrol Fire Marshal's Office manages a program to mobilize statewide resources to major incidents such as wildland fires and earthquakes. When statewide resources are insufficient to meet the demand, out of state resources can be mobilized through the Emergency Management Assistance Compact (EMAC), which provides for interstate mutual aid.

Participation in all-hazards mobilization benefits the district by providing our members with wildland firefighting and large incident experience which improves our ability to serve the community. In addition mobilization agreements provide revenue not only to pay the members who are mobilized, but also backfill to maintain district coverages, and payment for use of district apparatus. For example all-hazards mobilization to wildland fires in Okanogan, Chelan, and Thurston counties in 2020 generated \$70,000 in revenue for the district (approximately 50% of which was for personnel expenses and 50% was for the use of district apparatus).



The district has also implemented an innovative joint staffing program with North Whidbey Fire and Rescue (NWFR) and Camano Island Fire and Rescue. Under these agreements, apparatus can be jointly staffed by multiple agencies. This limits the staffing impact of mobilization and improves cooperation and coordination between agencies. Our first deployment with NWFR (left) was to the Bordeaux Fire in Thurston County.

Chief's Fireside Chat

2020 has been a challenging year for our community.

COVID-19

Early in the year we were faced with multiple challenges related to the COVID-19 pandemic and district staff worked closely with our partners at WhidbeyHealth and Island County to meet demand for emergency medical services while keeping our members safe. We worked closely with the Island County Incident Management Team to provide a coordinated fire and

emergency medical services (EMS) response and to assist in effective public communication regarding pandemic precautions. The district was fortunate to obtain a \$15,658 Assistance to Firefighters Grant from the Department of Homeland Security for COVID related expenses. This grant reimbursed the district for purchase of personal protective equipment and provided funding for further expenses related to pandemic response.

The district's community risk reduction efforts were significantly curtailed during the initial stages of the pandemic. Fire and life safety inspections for local businesses were postponed and we limited our home safety survey program to addressing homes without working smoke alarms. However, as we have moved through the phases of the Safe Start reopening plan, we have resumed all community risk reduction programs. In an effort to address fire inspection backlog and minimize impact on our business community we have worked with the Town of Coupeville and Island County to implement a self-inspection program for lower hazard business occupancies while restarting in-person inspections for occupancies in higher hazard categories.

Capital Bond Projects Update

In 2017, the district's voters approved a bond measure for the renovation and expansion of Station 53 on Race Road and the purchase of three type one (structural) fire engines to replace those at the end of their life-cycle. Midway through 2020, the district placed an order with Rosenbauer America for three engines and construction is underway with anticipated delivery in the third quarter of 2021. The district determined that it's more cost effective to replace the existing fire station, rather than expanding the existing building and attempting to bring it up to current seismic code. Island County required that the district go through a time consuming and arduous planning process to obtain a conditional use permit prior to issuance of a building permit. This process is nearly complete and we hope to break ground in April of 2021 with completion of the new station by April of 2022.

Coordinated Quality Improvement

The district has developed a coordinated quality improvement program to improve the quality of emergency medical care provided by our emergency medical technicians. In August we received approval of this program from the Washington State Department of Health making CWIFR one of the few fire service agencies in the state with an approved program.

Interagency Cooperation

In addition to joint staffing for all-hazards mobilization mentioned on page one, the district's Blue Card Command Training Center will provide several three-day simulation labs for staff from CWIFR, NWFR, and South Whidbey Fire/EMS. This joint training will significantly enhance our interoperability and effectiveness of automatic and mutual aid.

2021 Budget in Brief

The district's expenses exceed revenue in 2021. However, this was anticipated and beginning fund balances are sufficient to continue current service levels.


The district anticipates a 5.86% increase in assessed valuation (AV) which will lower the general levy rate to \$1.09/\$1,000 AV and the bond levy rate to \$0.18/\$1,000 AV.

The 2021 district budget increases general fund expenditures by 3.65% in large part due to increased staffing.




2021 Revenue Distribution
