

# COVID-19

As illustrated below, COVID-19 has had an ongoing impact on incident operations, but the frequency with which our members encounter it continue to fluctuate through the year. During the month of July, there were **30 incidents where COVID-19 was unknown/suspected and 0 with COVID-19 confirmed.** 




2023 Responses Where COVID was a Factor

# **Operational Activity**

During the previous month, the district had its busiest moth of the year and received **147 emergency calls** detailed below. The district **had 40 concurrent** incidents, **impacting 27% of total incidences.** Although we are back to our typical percentage of concurrent calls, this continues to strain our current staffing level and impact response times for a large proportion of our calls.

# **Station 53 Construction Project**

Construction is moving along nicely. Sheetrock is nearly taped and primed. Some cabinets are installed, Ceiling tile grid is up, and exterior siding are nearly complete. Grading, sidewalks, and curbing work are ongoing, septic system is installed and PSE has started the three-phase power upgrade by dropping off and installing the new underground power vaults.

# **Other Administrative work**

Chief Helm attended onsite construction meetings for station 53. Monthly planning meeting with Liz Loomis and the public communications team. Chief Helm attended the Island County Fire Chiefs, EMS council, and ICOM Fire Tac meetings. Had a collaborative meeting with Whidbey Health and ESO about collaboration and online patient report platform integration. Levy and fire department presentation to Windermere Relators of Whidbey. Volunteer Jim Mirabile continues work with EMS council on revamping the EMS bylaws. Contract negotiations with IAFF local 4299 continued with agreement on the new comparable agencies. We are still on track to meet our goal to ratify a new contract by the end of the year. Multiple staff participated in the ribbon cutting of the new boys and girls club. Chief Helm met with the new Island County Fire inspector and put him in touch with Lt. Porter for further collaboration.

### **Administrative**

Transitioned with DC Mirabile into new role and responsibilities until his departure (on August 11<sup>th</sup>). Set up computer accounts, completed HR paperwork, received uniforms and PPE, and configured assigned duty vehicle and MDC.

### **Recruitment**

Assisted FF Burnett with volunteer recruitment and orientation. There are currently six volunteer "recruits" in the process of getting equipment, initial training, and District policies and operations.

### **In-Service Training**

Assisted DC Mirabile with presenting the new Island County BLS protocols, including skills stations on cardiac emergencies, medical emergencies, trauma, cardiac arrest & CPR, and spinal immobilization. Assisted Lt. Jen Porter with Tuesday night drill on pre-connect stretches. Began preparing curriculum for upcoming Marine 5 orientation series of classes. Began planning and preparation to assist Division Chief Joe Dilley (SWFE) with upcoming EMT Academy.

### **Collaboration**

Had meetings with Captain Craig Anderson (OHFD), Division Chief Joe Dilley (SWFE), Dr. Krystal Bakciak (MPD), Rob May (WH-EMS), and Deputy Chris Garden (ICSO), Captain Chad McCoy (CIFR), to re-establish working relationships and lines of communications for future projects.

Completed pre-employment psychiatric evaluation, medical evaluation, stress test, and drug screening successfully. Reinstated Washington State EMT certification. Firefighter Steve Savros completed his engine apparatus operator task book with help from the shifts. Monthly CPR class conducted with AIC Lt Majestic and Volunteer CPR Instructor Jessica Caselden.
