

Subject: Chief's Report

#### **COVID-19**

As illustrated below, COVID-19 has had an ongoing impact on incident operations, but the frequency with which our members encounter it continue to fluctuate through the year. During the month of November, there were 48 incidents where COVID-19 was unknown/suspected and 1 with COVID-19 confirmed.




2023 Responses Where COVID was a Factor

#### **Operational Activity**

During the previous month, the district received 171 emergency calls detailed below. The district had 62 concurrent incidents, impacting 36% of total incidences. This continues to strain our current staffing level and impacted response times.

#### **Station 53 Construction Project**

Construction is nearing an end in sight.

Landscaping and sprinkler system installation is nearing completion

Paving of the parking lot should be completed by the end of this week (weather dependent)

Punch list on bedrooms and offices should start Monday which will allow us to start moving furniture in to these areas by the end of next week. The water and generator seem to still be a slow point with significant delays. Many Island County permits are slowly being completed and signed off, but a majority of the remaining ones involve water and the back up generator. External civil work should wrap up by the end of next week with construction of the retention pond. We anticipate Temporary occupancy and a big push for move in around the middle of January.

#### **Other Administrative work**

Chief Helm attended multiple onsite construction meetings for station 53. Chief Helm attended the Island County Fire Chiefs, EMS council, and ICOM Fire Tac meetings. Volunteer Jim Mirabile continues work with the EMS council on revamping the EMS bylaws and we utilized the districts lawyer for review of these documents to be paid by the EMS council. Chief Helm attended and acted as an evaluator for a captain position for Tulalip Fire Department. Significant time was spent by Chief Helm and Cathy Niiro to finalize the 2024 budget once the levy results were in. Worked with Liz Loomis on final public messaging and post-election social media post.

#### **Training & Development**

#### **Administrative**

Administered (proctored) the final series of on-line Island County BLS protocol test to District members. Administered the Narcan skill stations to all District EMT's per Dr. Baciak's protocol requirement. Continued planning for the dedication ceremony for the grand opening of Station 53. Continued planning the logistics of moving into Station 53.

#### **Recruitment**

Met with FF Travis Dotson to develop a recruitment, orientation, and training plan for the volunteer members. Dotson will take a lead role within the volunteer group to improve coordination and communications. Reviewed the curriculum for the new volunteer orientation session.

#### **In-Service Training**

Instructed classroom sessions on OTEP-required patient assessment, practical hands-on drill on vehicle stabilization and scene safety at motor vehicle accidents, and a practical hands-on drill on the use of small tools and chain saws.

#### **Collaboration**

Continued planning sessions with ICSO, Emergency Management, and WhidbeyHealth EMS on "full scale" active shooter/MCI drill that is planned for Coupeville High School in January. Reviewed the life safety and fire protection systems at the newly-renovated LDS church that is now an overnight shelter operated by the South Whidbey Coalition for the Homeless.

#### Other

Facilitated multi-agency post-traumatic stress debriefing session at WhidbeyHealth hospital following a fatal tractor accident this month.

FF/EMT John Lloyd participated in a week-long rope/technical rescue class with SWFE.

Crews are diligently working on their Washington State Boater Certifications and a majority of our career personnel.

- 4. Lt. Porter participated in a lieutenant assessment center for OHFD.
- 5. Lt. Porter participated in live fire training with OHFD.
- 6. A-shift and Debby Jackson (Thank you Debby!) spent a significant amount of time readying the Santa Mobile for our December adventures. FF Justin Burnett has spent countless hours ensuring the program goes smooth. Santa Mobile is underway and is going great with great turnouts from our community and lots of food donations for the food bank.
- 7. B-shift responded to a vehicle rollover on Madrona Way with entrapment, AIC Lt. Alex Majestic and Lt. Jim Huff did a great job assessing the situation and safely removing the patient through the front windshield. Driver was mostly un-injured.
- 8. C-Shift responded to a motorcycle vs deer, AIC Lt. John Lloyd and FF Steve Stavros took command of the scene and called for an additional ambulance. The crew did a great job recognizing extensive injuries that were not initially apparent and made a great call in calling for additional help.

# **Repair and Maintenance**

- Unit 2102 (E53) E53's firecom issues were diagnosed and repaired, fixing issues crews were having with communication and dispatch. The water tank level indicator was also giving improper readings, this was diagnosed and repaired
- 2. SWFE Unit 1204 Matros conducted repairs on the trucks air system and passed off the remaining portion of this job to SWFE's new fire mechanic.
- 3. Unit 1401 (Reserve) 1401 has been moved to Station 54 after it's long stay at Station 31. Repairs were conducted on the pump master drain that was found frozen on inspection by Matros.
- 4. Unit 1101 (Matrix) Diagnosed and repaired a failed startup.
- 5. Unit 1402 (Tahoe) Multiple trips to Main Street Collision for parts removal. These parts are being utilized on the recently procured Dodge P/U and Tahoe.
- 6. Unit 2001 (B54) Received new batteries.

#### **Other Fleet Maintenance Activity**

During the month of November FF/Mechanic Matros continued work on CWIFR's new fleet maintenance truck. This process will continue as time permits; the primary focus is to upfit the two new vehicles added to the fleet in November.
