Subject: Chief's Report


Operational Activity

During the previous month, the district received **119 emergency calls** and had **13 concurrent incidents** impacting **11% of total incidences**. **31.1%** Fire response and **68.9%** EMS emergency response.

Other Administrative work

Chief Helm attended the Island County Fire Chiefs, EMS council, and ICOM Fire Tac meetings. Chief Helm met multiple days with South Whidbey regarding collaboration efforts.

Assisted Oak Harbor Fire with assessment center, conducted closeout interviews with the wildland team that was deployed to California, attended a virtual demonstration for Vector solutions scheduling platform. Cathy completed work on 2024 end of year report, and held a staff meeting for all full-time employees.

Training & Development

Administrative

Firefighter/EMT Travis Dotson and Battalion Chief Lloyd are making significant progress on the proposed draft of SOG 1.2.5 Volunteer Personnel. This SOG outline requirements for Volunteers activity levels, ranks and roles, compensation, working conditions and training. Volunteer applications are being received and reviewed by Battalion Chief Lloyd and interviews should start again late May or early June.

Recruitment

We will be participating in the "Hustle With Heroes" 5K race on May 31st in Coupeville. This is a joint fund-raising effort by all Whidbey Island public safety agencies with the race proceeds benefiting the Whidbey Island Boys & Girls Club. We will be staffing a information tent at the race and will be answering questions and making volunteer applications available.

In-Service Training

We completed more than 250 hours of training this month. Subjects included-

Collaboration

The 2025 Island County Fire Academy is complete with the graduation yesterday. Chief Magallon from South Whidbey Fire/EMS and I will begin planning interagency training when time allows and hopefully start that in June. Interagency training strengthens are abilities when working together and gives us additional knowledge from outside our agency and different perspective.

<u>Other</u>

The Marine Academy will be held from May 14th through May 16th. All six probationary firefighters will participate, supported by Firefighter Kellison and Battalion Chief Lloyd. This joint academy, conducted in partnership with Camano Fire, marks the initial step toward marine qualification and operational readiness for boat deployment. The timing is ideal, preceding the peak of the busy water activity season.

Operations

WSRB Site Visit and Follow-Up

Central Whidbey Island Fire & Rescue welcomed representatives from the Washington Surveying and Rating Bureau (WSRB) on April 9th as part of our routine five-year rating review. Chief Helm and Deputy Chief Meek provided supplemental information during the visit, after which the WSRB issued a list of follow-up action items for CWIFR to complete before finalizing the rating. Most of these items pertain to water system data. We are working with multiple water system providers to collect and submit the required information. Chief Helm and Deputy Chief Meek are scheduled to meet with the Whidbey Island Water Systems Association on June 17, 2025, to discuss hydrant testing and inspection coordination.

Safety Committee Launch

On April 17th, Firefighter Justin Burnett, EMT Mark Valencia, and I held the inaugural meeting of CWIFR's new Safety Committee. This initial session focused on understanding the committee's purpose and beginning to develop initiatives to foster a healthier and safer environment for all personnel. The committee is reviewing project proposals for a potential grant submission through the L&I FIIRE Program to reduce carcinogen exposure and musculoskeletal injuries.

SCBA Washer Installation

CWIFR has received the new SCBA washer, which was purchased through a combination of L&I FIIRE Program grant funds and department resources. Installation is underway, and we anticipate that the SCBA washer and the PPE dryer will be operational by June 2025.

NERIS Onboarding

All required documentation has been submitted to the Assistant Deputy State Fire Marshal for onboarding into the National Emergency Response Information System (NERIS). We are currently awaiting feedback and further instructions.

Station 53 Facility Updates

We continue to collaborate with Tiger Construction to address minor outstanding issues at Station 53. Over the past month, Tiger has replaced several emergency exit signs, repaired malfunctioning light switches, and is addressing a few remaining items.

- Replacement software and helmets ordered for rope rescue. 10-year life span replacement.

PPE/Respiratory Protection

- Scheduled LN Curtis to arrive on April 1st to take custom measurements of six firefighters (including the new hires) for new bunker Gear.
- Received eight new sets of bunker pants. Logged them into ESO and issued them to the appropriate firefighter(s).
- Received bids for new bunker gear, hanging tags, and bunker boots. Submitted for approval and ordered all gear.
- Old PPE transferred to Skagit Valley Community College.
- Organized PPE Room.
- Issued gear to the three new firefighters who started on May 1st.
- Ordered loaner gear for FF McCallum from LN Curtis.
- Two SCBAs sent in for repair.

Radios/Pagers

- SWFE has loaned us two radios to outfit M5 and 505.
- No update from Skagit 911 or ICOM on the new portables.

Repair & Maintenance

- Unit 0701 (T-53) Rebuilt primer actuating valve due to corrosion and leakage. Removed and rebuilt the pump overheat valve due to leakage.

- Unit 1401 Completed pump panel reconfiguration and valve controller installation. Calibrated new valves, rebuilt primer actuating valve, fabricated and installed custom rollers for crosslay trays to slide over. Replaced two cracked Class One discharge gauges. Cummins NW Tech repaired the aftertreatment system.
- Unit 2101 (E-51) Receiving its 750hr preventative maintenance cycle and NFPA 1911 inspection.
