

Subject: Chief's Report

Operational Activity

For the month of October 2025, we received **167 emergency service calls.** Of those, **30 overlapping incidents** impacted **17% of total incidents**. **2.4%** Fire response, **37.1%** Other response, and **60.5%** EMS emergency response.

Station 53 Construction Project

There are no new updates for Station 53, as our new SCBA washer, which was replaced under warranty, is awaiting installation.

Other Administrative work

Chief Helm attended the monthly EMS Council and Fire Tac meeting. Chief Helm met multiple days with South Whidbey regarding collaboration efforts and leadership meeting collaborations. Chief Helm, finance officer Cathy Niiro, and commissioners Engle and Mesner attended the Washington Fire Commissioners conference. October also saw a considerable amount of time finalizing and preparing the 2026 proposed district budget. Chief Helm also assisted the Oak Harbor Fire Department as an assessor for their anticipated Deputy Chief hiring. Deputy Chief Meek assisted North Whidbey Fire with their Battalion Chief hiring process. Also, Chief Helm hosted the public budget hearing open house on October 29th at Station 53.

Training & Development – Battalion Chief John Lloyd

We continue to collaborate with South Whidbey Fire/EMS on training with new the joint Battalion Chief position in place. Chief Magallon is leading the development of the training schedule, while Chief Burbank, the crews, and I are overseeing and administering the training. We are making steady progress toward establishing a strong training program.

Collaboration

South Whidbey Fire/EMS and our department continue to work collaboratively on training development. We are in the early stages of planning a Multiple Casualty Incident (MCI) drill scheduled for early next year. The exercise will likely focus on triage operations and response procedures for large-scale events such as a major storm or earthquake. We also anticipate involving additional partner agencies from across Island County to enhance interagency coordination and preparedness.

Community Partnerships

October marked Fire Prevention Month nationwide, and Central Whidbey Island Fire & Rescue (CWIFR) received multiple requests from local organizations for fire prevention presentations and outreach. Throughout the month, CWIFR personnel conducted or participated in the following community engagements:

CWIFR also proudly represented the community during the annual Torchlight Parade, with participation from Travis Dotson, Jesse Carranza, and Finance Officer Cathy Niiro. In addition, B-Shift attended the Trunk or Treat event at Living Hope Church on Halloween. The crew did an exceptional job decorating A503 and helping provide a safe, memorable evening for local families.

CWIFR continues to collaborate with Island County on developing proposed language for the *Testing Protocols* for Water and Sewer Franchises. The goal is to ensure that all hydrants within our service area are tested and inspected in accordance with Washington Surveying and Rating Bureau (WSRB) standards.

CWIFR has also been coordinating closely with the State Fire Marshal's Office to maintain compliance and ensure on-schedule progress toward the nationwide transition from NFIRS to NERIS, effective January 1, 2026. Personnel training will take place throughout November and December, and Deputy Chief Meek is preparing a comprehensive *NERIS Guide* to support this transition.

Finally, Deputy Chief Meek participated as an evaluator for NWFR's Battalion Chief Assessment Center.
